96/21 HEREFORDSHIRE COUNTY COUNCILLOR Terry James explained that meetings on ZOOM for the past 12 months had been awful. He advised that the By-Pass had been cancelled and that HC would have to repay £12.5 million – when asked what had been spent – advised that compulsory purchasers etc. Mr James went on to advise the Council that the Children's Services were dreadful with the High Court Judge stating that it was the worst thing he had seen. Mr James went on to give examples of the actions of the persons in Children's Services and he also advised that he had warned the powers that be that there was a problem. £5.5 million has been put to cover the legal costs.

#### 108/21 ROADS

Cllr J Jones reported that the road from Walton to the Womaston turn which was in Powys was in excellent condition but from the Womaston turn up and through Lower Harpton there were potholes etc. Clerk asked if the subsidence had been dealt with and Cllr Jones said no.

Cllr P Watkins reported potholes in Dunfield Lane

Cllr D Sankey reported that from beyond the Bullocks Mill Farm and down to the river there were potholes, but where the road runs up and beyond the bridge towards Lyonshall there were no potholes!

Cllr H Davies reported that the salt bins were broken in Barton Lane and needed replacing – also that there were potholes in Barton Lane.

### 109/21 Reports from Councillors & Officials

Cllr P Watkins reported the increase in parking charges in Mill Street - originally at Kington Primary School where the children are dropped off there were no car parking charges and that the charges only started at 9am after school had started and then stopped at 3pm. Now the charges are starting at 8am and there is chaos dropping off the children for school. The matter is not helped by the warden being present.

County Councillor T James advised that we send a letter to John Harrington of Hereforshire Council advising that we are appalled by the time change and that there are child safety issues.
